A Resolution authorizing the County Executive to execute a contract with the Akron/Summit Convention and Visitors Bureau to provide the services of a convention bureau to promote Summit County as a location for holding conventions and to further convention activities in the County, for a five-year term, from 1/1/16 through 12/31/20, for its portion of the annual proceeds of the lodging excise tax, for the Executive, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2011-029, which authorized the County Executive to execute a contract with the Akron/Summit Convention and Visitors Bureau to provide the services of a convention bureau to promote Summit County as a location for holding conventions and to further convention activities in the County, for a five-year term, from 1/1/11 through 12/31/15, for its portion of the annual proceeds of the lodging excise tax; and

WHEREAS, Section 703.13 of the Codified Ordinances of the County of Summit and Section 5739.09 of the Ohio Revised Code provide for the allocation of proceeds of the hotel lodging excise tax to the Bureau to provide such services; and

WHEREAS, the County wishes to execute a new five-year contract with the Bureau to provide such services, for the period of 1/1/16 through 12/31/20, for its portion of the annual proceeds of the lodging excise tax; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the Executive to execute the aforementioned contract is necessary and in the best interest of the County of Summit.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

RESOLUTION NO

The County Executive is hereby authorized to execute a contract with the Akron/Summit Convention and Visitors Bureau to provide the services of a convention bureau to promote Summit County as a location for holding conventions and to further convention activities in the County, for a five-year term, from 1/1/16 through 12/31/20, for its portion of the annual proceeds of the lodging excise tax.

## SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the County of Summit, and for the further purpose that it is necessary in order to authorize the Executive to immediately execute a contract with the Akron/Summit Convention and Visitors Bureau prior to the expiration of the existing contract.
