7 **A Resolution authorizing the County Executive to advertise for bids for moving furniture**
8 **to the new County offices located at 1180 South Main Street, Akron, Ohio, for an estimated**
9 **amount not to exceed \$150,000.00, for the Executive's Department of Administrative**
10 **Services – Division of Physical Plants, declaring an emergency.**

12 WHEREAS, 8 departments from 7 locations are being moved to the new County offices
13 located at 1180 South Main Street, Akron, Ohio 44301, in Council District 4; and

14
15 WHEREAS, it will be necessary to move existing furniture for over 70 offices, numerous
16 conference rooms, computers, chairs, storage shelves and the County Record Center, which can
17 be accomplished in four weekends by hiring outside personnel to undertake the move; and

18
19 WHEREAS, it is necessary to authorize the County Executive to advertise for bids for
20 moving furniture to the new County offices located at 1180 South Main Street, Akron, Ohio, for
21 an estimated amount not to exceed \$150,000.00; and

23 WHEREAS, a copy of the bid specifications are attached to this Resolution as Exhibit A;

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 for bids for moving furniture to the new County offices located at 1180 South Main Street,
29 Akron, Ohio, for an estimated amount not to exceed \$150,000.00;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is authorized to advertise for bids for moving furniture to the new
37 County offices located at 1180 South Main Street, Akron, Ohio 44301, in Council District 4, for
38 an estimated amount not to exceed \$150,000.00.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit and for the further reason that it is immediately
44 necessary in order to provide for moving furniture to the new County offices located at 1180
45 South Main Street, Akron, Ohio.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
