## SECTION 1

The County Executive is authorized to advertise for bids for 2015-2016 winter season plowing and salting of County parking lots at several locations, including the Summit County Jail, the Juvenile Court/Detention, Ohio Means Jobs Summit County and Title Bureau on Tallmadge Ave., the Medical Examiner's Office and the Summit County Animal Control Facility, in Council Districts 2 and 4, for an estimated total cost not to exceed \$35,000.00.

This Resolution is declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason that it authorizes the Executive to immediately advertise for bids for 2015-2016 winter season plowing and salting of County parking lots at several locations, in Council Districts 2 and 4, for an estimated total cost not to exceed \$35,000.00.
