7 **A Resolution confirming an award by the Board of Control of a IV-D intergovernmental**  
8 **agreement with the County of Summit Court of Common Pleas - Juvenile Division to allow**  
9 **the County Prosecutor's Child Support Enforcement Agency to reimburse the Court for**  
10 **magistrate service expenses, for a one-year term, from 10/1/15 through 9/30/16, in an**  
11 **amount not to exceed \$74,809.02, for the Prosecutor – Child Support Enforcement Agency,**  
12 **and declaring an emergency.**

13  
14 WHEREAS, the Board of Control, at its meeting held August 26, 2015, awarded a IV-D  
15 intergovernmental agreement with the County of Summit Court of Common Pleas - Juvenile  
16 Division to allow the County Prosecutor's Child Support Enforcement Agency to reimburse the  
17 Court for magistrate service expenses, for a one-year term, from 10/1/15 through 9/30/16, in an  
18 amount not to exceed \$74,809.02, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the aforementioned intergovernmental agreement with the Juvenile Division is necessary  
22 and in the best interest of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a IV-D intergovernmental agreement with the  
30 County of Summit Court of Common Pleas - Juvenile Division to allow the County Prosecutor's  
31 Child Support Enforcement Agency to reimburse the Court for magistrate service expenses, for a  
32 one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$74,809.02, is hereby  
33 confirmed and the County Executive is hereby authorized to execute such intergovernmental  
34 agreement.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason to immediately  
40 provide for the reimbursement of the Juvenile Division for magistrate services effective 10/1/15.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.
