A Resolution confirming an award by the Board of Control of Change Order No. 1 to a professional service contract with the Battered Women's Shelter of Summit and Medina Counties for homeless prevention services at various shelters, for a one-year term, from 10/1/14 through 9/30/15, in an amount not to exceed \$50,000.00 (28.57% increase) for a total amount not to exceed \$225,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2014-357, which confirmed an award by the Board of Control of a professional service contract with the Battered Women's Shelter of Summit and Medina Counties for homeless prevention services at various shelters, for a one-year term, from 10/1/14 through 9/30/15, in an amount not to exceed \$175,000.00; and

WHEREAS, the Board of Control, at its meeting held August 26, 2015, awarded Change Order No. 1 to the aforementioned professional service contract with the Battered Women's Shelter of Summit and Medina Counties in an amount not to exceed \$50,000.00 (28.57% increase) for a total amount not to exceed \$225,000.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, by reviewing all pertinent information, that the aforementioned Change Order No. 1 to the professional service contract with the Battered Women's Shelter of Summit and Medina Counties is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
