A Resolution confirming an award by the Board of Control of a renewal (second of two) of a professional service contract with Anthem to provide life and accidental death and dismemberment coverage for County employees, and voluntary employee, spouse and dependent life and accidental death and dismemberment coverage, for a one-year term, from 1/1/16 through 12/31/16, for an estimated total amount not to exceed \$539,000.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, the Board of Control, at its meeting held 9/9/15, awarded a renewal (second of two) of a professional service contract with Anthem to provide life and accidental death and dismemberment coverage for County employees, and voluntary employee, spouse and dependent life and accidental death and dismemberment coverage, for a one-year term, from 1/1/16 through 12/31/16, in an amount not to exceed \$.05 per \$1,000.00 of basic life coverage and \$.01 per \$1,000.00 of accidental death and dismemberment coverage, for an estimated total amount not to exceed \$539,000.00, subject to confirmation by County Council; and
