7 **A Resolution authorizing the County Executive to advertise for bids for the Juvenile Court**  
8 **Kitchen Floor Replacement Project, for an estimated total cost not to exceed \$50,500.00,**  
9 **for the Executive's Department of Administrative Services- Physical Plants Division, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the Juvenile Court  
16 Kitchen Floor Replacement Project, for an estimated total cost not to exceed \$50,500.00, which  
17 will overlay the existing kitchen floor at the Juvenile Court Facility, which is a difficult to clean  
18 rough surface, with a rubber floor system similar to the current floor in the Summit County Jail's  
19 kitchen; and

21 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 advertise for bids for the Juvenile Court Kitchen Floor Replacement Project, for an estimated  
26 total cost not to exceed \$50,500.00;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

33 The County Executive is authorized to advertise for bids for the Juvenile Court Kitchen  
34 Floor Replacement Project, for an estimated total cost not to exceed \$50,500.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
39 of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for the Juvenile Court Kitchen Floor Replacement  
41 Project, for an estimated total cost not to exceed \$50,500.00.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
