A Resolution confirming an award by the Board of Control of a renewal (first of four) of a purchase contract with Metro Regional Transit Authority, as a Best Practical Source, to provide transportation services for work mandated recipients, for a one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$187,500.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned renewal of a purchase contract with Metro Regional Transit Authority is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a renewal (first of four) of a purchase contract with Metro Regional Transit Authority, as a Best Practical Source, to provide transportation services for work mandated recipients for the Executive's Department of Job and Family Services ("DJFS"), for a one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$187,500.00, is hereby confirmed and the County Executive is hereby authorized to execute such purchase contract.
