A Resolution authorizing the County Executive to execute any documents necessary to accept the award of a 2014 Title II Formula Grant from the Ohio Department of Youth Services to impact minority youth arrests in Summit County, for the period 10/1/15 through 9/30/16, in the amount of \$9,693.00, and appropriating said grant funds and \$5,000.00 in supplemental RECLAIM Ohio funds, for a total amount of \$14,693.00, for the Court of Common Pleas - Juvenile Division, and declaring an emergency.

WHEREAS, the Ohio Department of Youth Services has awarded the Court of Common Pleas - Juvenile Division a 2014 Title II Formula Grant from the Ohio Department of Youth Services, for the period 10/1/15 through 9/30/16, in the amount of \$9,693.00, with no local cash match requirement; and

WHEREAS, these funds will be used to provide 25% of the costs of the salary of a probation officer; and

WHEREAS, RECLAIM Ohio funds, in the amount of \$5,000.00, will be used to supplement the 2014 Title II Formula Grant by paying for benefits associated with the 25% of salary costs covered by said grant;

WHEREAS, it is necessary to appropriate the 2014 Title II Formula Grant and the RECLAIM Ohio funds, in a total amount of \$14,693.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned 2014 Title II Formula Grant and to appropriate said grant funds and RECLAIM Ohio funds, in a total amount of \$14,693.00;
