A Resolution authorizing the County Executive to submit an application and proposal to the Ohio Development Services Agency for grants funded by the U.S. Department of Energy and U.S. Department of Health and Human Services, with no local cash match requirement, for the operation of a Program Year 2016 Home Weatherization Assistance Program for the period 7/1/16 through 6/30/17, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the Ohio Development Services Agency ("ODSA") estimates that for Summit County, approximately \$360,282.00 will be available from the U.S. Department of Energy ("DOE") and approximately \$777,497.00 from the U.S. Department of Health and Human Services ("HHS"), for an estimated total of \$1,137,779.00, with no local cash match requirement, for the operation of a Program Year 2016 Home Weatherization Assistance Program ("HWAP") for the period 7/1/16 through 6/30/17; and

WHEREAS, as part of the application and submission of a proposal in response to the ODSA's Request for Proposals ("RFP"), the ODSA requires an applicant to "submit a Resolution by the organization's governing Board or other Authority approving the submission of a proposal in response to this RFP;" and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to submit an application and proposal to the ODSA for grants funded by DOE and HHS, with no local cash match requirement, for the operation of a Program Year 2016 HWAP for the period 7/1/16 through 6/30/17;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
