WHEREAS, ROW acquisition is considered a "local cost" which must be borne in whole by the local public agency performing a project, in this case being the County of Summit; and

WHEREAS, acquisition of the subject standard highway and temporary easements will promote proceeding with the Project to bid; and

WHEREAS, this Council has determined by reviewing all pertinent information that the acceptance and approval of the aforementioned standard highway and temporary easement acquisitions are necessary and in the best interest of the County of Summit;
