WHEREAS, the County wishes to enter a renewal (first of four) of a professional service contract with Proware, for case management system software support and maintenance services, as a Best Practical Source, subject to Board of Control approval and IT Board approval, or the period of 1/1/16 through 12/31/16, in an amount not to exceed \$159,750.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned renewal of a professional service contract with Proware is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award of a renewal (first of four) of a professional service contract with Proware, for case management system software support and maintenance services, as a Best Practical Source, subject to Board of Control approval and IT Board approval, for the period of 1/1/16 through 12/31/16, in an amount not to exceed \$159,750.00 is hereby confirmed and the County Executive is hereby authorized to execute such professional service contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further purpose of immediately authorizing the Executive to execute a necessary professional service contract to provide for case management system software support and maintenance services effective 1/1/16.
