7 **An Ordinance amending Chapter 177 of the Codified Ordinances of the County of Summit**
8 **to make certain updates and revisions to the purchasing process of the County, for the**
9 **Executive's Department of Finance and Budget, and declaring an emergency.**

11 WHEREAS, the County Executive has recommended certain revisions to Chapter 177 of
12 the Codified Ordinances of the County of Summit, entitled "Board of Control; Contract
13 Procedures," to update and revise certain purchasing practices of the County; and

14
15 WHEREAS, such updates and revisions should improve efficiencies in the County's
16 process concerning the award of professional service contracts and the sale, transfer or disposal
17 of County personal property by authorizing said transfers by both on-site and internet auctions;
18 and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to amend Chapter 177 of the
22 Codified Ordinances of the County of Summit as recommended by the Executive;

24 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
25 of Ohio, that;

27 SECTION 1

29 Chapter 177 of the Codified Ordinances of the County of Summit is hereby amended as
30 set forth in Exhibit A, attached to this Ordinance and incorporated herein as if fully restated.

32 SECTION 2

34 This Ordinance is declared an emergency in the interest of the health, safety, and welfare
35 of the citizens of the County of Summit, and for the further reason of immediately amending
36 Chapter 177 in order to immediately update, revise and streamline certain purchasing processes
37 of the County.

39 SECTION 3

41 Provided this Ordinance receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

45 SECTION 4

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and any of its committees that resulted in such formal action, were
50 in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.
