A Resolution authorizing the County Executive to execute a professional service contract with Medical Mutual of Ohio, subject to the approval of the Board of Control, to provide stop-loss reinsurance for County employees for a one-year term, from 1/1/16 through 12/31/16, for a total amount not to exceed \$304,062.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, on behalf of the County of Summit, EBI prepared a request for proposals for stop-loss reinsurance for County employees and the County has selected Medical Mutual of Ohio to provide said stop-loss insurance; and

WHEREAS, the Executive's Department of Law, Insurance and Risk Management recommends that the County Executive be authorized to execute a professional service contract with Medical Mutual of Ohio, subject to the approval of the Board of Control, to provide stoploss reinsurance for County employees for a one-year term, from 1/1/16 through 12/31/16, in an amount not to exceed \$9.17 per employee per month, for a total amount not to exceed \$304,062.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a professional service contract with Medical Mutual of Ohio, subject to the approval of the Board of Control, to provide stoploss reinsurance for County employees for a one-year term, from 1/1/16 through 12/31/16, in an amount not to exceed \$9.17 per employee per month, for a total amount not to exceed \$304,062.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately authorize the Executive to execute a necessary professional service contract to provide stop-loss reinsurance for County employees effective 1/1/16.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
