**An amended Resolution appropriating carryover funds in multiple grant awards including the Metropolitan Medical Response System (“MMRS”), both the Local and Regional State Homeland Security Programs (“SHSP”), and the Search and Rescue Capability Program, in the total amount of ~~\$1,054,146.50~~ \$1,057,984.09, for 2010, for the Executive’s Division of Public Safety-Emergency Management Agency and declaring an emergency.**

WHEREAS, the State Fiscal Year 2007 and State Fiscal Year 2008 MMRS awards provide funding to better mitigate, prepare, respond, and recover from acts of terrorism and other disasters were accepted and appropriated in R08-010 and R09-335 have carryover balances; and

WHEREAS, the State Fiscal Year 2007 and State Fiscal Year 2008 local SHSP awards accepted and appropriated in R08-011 and R09-238 have carryover balances which must directly support Ohio’s Investment Initiative and center on the prevention of acts of terrorism and other disasters of the homeland security mission; and

WHEREAS, the State Fiscal Year 2007 Regional SHSP award provides funds to purchase equipment to support the Hazardous Materials Response Teams within the NECO Region 5 area and has carryover balances from R08-058 and R09-034 available through 3/31/10; and

WHEREAS, the State Fiscal Year 2010 Search and Rescue Capability grant funds materials and training to support a stronger search and rescue team was accepted in R09-435 and requires appropriation in 2010; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned carryover grant funds in the total amount of ~~\$1,054,146.50~~ \$1,057,984.09;
