A Resolution appropriating carryover grant funds received from the U. S. Department of Justice for the Domestic Violence Unit/Strategic At-Risk Family Education (“DVU/S.A.F.E.”) Program, in the amount of \$430,122.00, through 12/31/10, for the Prosecutor, and declaring an emergency.

WHEREAS, the U.S. Department of Justice has provided a supplemental award of \$749,970.00 to the County Prosecutor’s Office for its DVU/S.A.F.E. Program in order to develop and strengthen effective responses to violence against women by encouraging arrest policies and enforcement of protection orders; and

WHEREAS, this supplemental award, which was accepted by the County Executive pursuant to Resolution No. 2009-374, is for a program period through 6/30/11 and provides for the collaboration with Battered Women’s Shelter of Summit and Medina Counties, Inc., the Victim Assistance Program, Inc., and the County of Summit Adult Probation Department; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate carryover funds from the aforementioned grant award, in the amount of \$430,122.00. through 12/31/10;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
