1. SCOPE OF SERVICES

Provide armed security guard services at the following location: Summit County Veterans Service Commission located at 1060 E. Waterloo Rd., Akron, OH 44306.

Length of contract: 9 Months, with option for one additional year.

Hours: Monday through Friday: 8:00 A.M. to 4:00 P.M., except for Wednesdays 1:00 PM to 4:00 PM.

Supervision: Guard service is to provide off site supervision for security guard, proper relief and training as necessary.
