WHEREAS, on April 13, 2009, County Council adopted Resolution No. 2009-112, whereby the County of Summit Voluntary Separation Plan ("the Plan") was authorized and approved, the County Executive was authorized to administer the Plan and the Plan was made available to all County appointing authorities, offices, agencies, boards and commissions ("Office/Offices"); and

WHEREAS, on June 29, 2009, County Council adopted Resolution No. 2009-272, transferring mandatory salary savings in the General Fund to cover the cost of employee payouts; and

WHEREAS, on September 28, 2009, County Council adopted Resolution No. 2009-360, whereby the Plan was re-opened, authorized and approved, the County Executive was authorized to administer the Plan, the Plan was made available to all County Offices and as stated in Exhibit A, employees may elect to be paid half of all payouts in 2009 upon separation of employment and half of the payouts between January 1, 2010 and January 31, 2010; and

WHEREAS, on November 2, 2009, County Council adopted Resolution No. 2009-440, whereby certain employees were permitted to participate in the Plan, despite missing the deadline, allowing the County to realize additional savings; and

WHEREAS, on November 30, 2009, County Council adopted Resolution No. 2009-471, whereby funds were appropriated in the General Fund and other operating funds to meet separation costs for 2009 related to the Plan; and

WHEREAS, additional appropriations are required to cover the year 2010 cost of employee payouts in the General Fund and other operating funds of the County; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned funds:
