7 **A Resolution authorizing the County Executive to advertise for bids for Heating,**  
8 **Ventilation and Air Conditioning (“HVAC”) maintenance at the County of Summit Safety**  
9 **Building for a five-year period, for an estimated cost not to exceed \$19,000.00 per year, for**  
10 **a total estimated amount not to exceed \$95,000.00, in Council District 4, for the Executive’s**  
11 **Department of Administrative Services, and declaring an emergency.**

13 WHEREAS, the County of Summit desires to authorize the County Executive to  
14 advertise for bids for Heating, Ventilation and Air Conditioning (“HVAC”) maintenance at the  
15 County of Summit Safety Building for a five-year period, for an estimated cost not to exceed  
16 \$19,000.00 per year, for a total estimated amount not to exceed \$95,000.00; and

18 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of  
19 Council; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
22 necessary and in the best interest of the County of Summit to authorize County Executive to  
23 advertise for bids for HVAC maintenance at the County of Summit Safety Building for a five-  
24 year period, for an estimated cost not to exceed \$19,000.00 per year, for a total estimated amount  
25 not to exceed \$95,000.00;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that;

29 SECTION 1

31 The County Executive is authorized to advertise for bids for Heating, Ventilation and Air  
32 Conditioning (“HVAC”) maintenance at the County of Summit Safety Building for a five-year  
33 period, for an estimated cost not to exceed \$19,000.00 per year, for a total estimated amount not  
34 to exceed \$95,000.00, in Council District 4.

38 This Resolution is hereby declared an emergency in the interest if the health, safety, and  
39 welfare of the citizens of the County of Summit, and for the further reason that it immediately  
40 allows for the advertising for bids for HVAC maintenance at the County of Summit Safety  
41 Building.

42 SECTION 3

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
