7 **A Resolution authorizing the County Executive to execute a lease agreement, subject to the**
8 **approval of the Board of Control, with the Twinsburg Public Library for approximately**
9 **573.5 square feet of space at the Twinsburg Public Library, located at 10050 Ravenna**
10 **Road, Twinsburg, Ohio 44087, in Council District 1, to be used as a Transition Center to**
11 **provide services to displaced workers and assist them in locating and securing new**
12 **employment, for the period of 3/1/10 through 6/30/11, for a rent not to exceed \$900.00 per**
13 **month or \$14,400.00 for the term of the lease, to be paid by the County of Summit using**
14 **Workforce Investment Act Rapid Response grant funds, for the Executive's Department of**
15 **Job and Family Services, and declaring an emergency.**

17 WHEREAS, the County of Summit wishes to execute a lease agreement with the
18 Twinsburg Public Library for approximately 573.5 square feet of space at the Twinsburg Public
19 Library, located at 10050 Ravenna Road, Twinsburg, Ohio 44087, in Council District 1, to be
20 used as a Transition Center to provide services to displaced workers and assist them in locating
21 and securing new employment, for the period of 3/1/10 through 6/30/11, for a rent not to exceed
22 \$900.00 per month or \$14,400.00 for the term of the lease; and

24 WHEREAS, the rent for the aforementioned lease will be paid by the County using
25 Workforce Investment Act Rapid Response grant funds; and

27 WHEREAS, the aforementioned lease is subject to the approval of the Board of Control;

31 necessary and in the best interest of the County of Summit to authorize the County Executive to

42 Twinsburg, Ohio 44087, in Council District 1, to be used as a Transition Center to provide
43 services to displaced workers and assist them in locating and securing new employment, for the
44 period of 3/1/10 through 6/30/11, for a rent not to exceed \$900.00 per month or \$14,400.00 for
45 the term of the lease. The rent for the aforementioned lease will be paid by the County using
46 Workforce Investment Act Rapid Response grant funds.
