13 purchase order for fuel, under CUE pricing, subject to confirmation by County Council; and,

16 the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a purchase order with Port's Petroleum Company  
24 for fuel, under CUE pricing, in an amount not to exceed \$200,000.00, is hereby confirmed, and  
25 the County Executive is authorized to execute such a purchase order.

29 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
30 welfare of the citizens of the County of Summit and for the further reason of immediately  
31 providing fuel.

35 Provided this Resolution receives the affirmative vote of eight members, it shall take  
36 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
37 effect and be in force at the earliest time provided by law.

42 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
43 deliberations of this Council and of any of its committees that resulted in such formal action,

45 121.22 of the Ohio Revised Code.
