A Resolution authorizing the County Executive to execute a renewal (1st of 4) of and addendum to the renewal of a lease with United Disability Services, Inc. for approximately 1,280 square feet of space located at 264 S. Arlington Street, Akron, in Council District 4, for cafeteria operations, for a one-year term, from 11/20/09 through 11/19/10, with three options to renew for an additional one-year term, for rent of \$1.00 per year, for the Executive's Department of Law, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2008-386, which confirmed the award by the Board of Control of a lease with United Disability Services, Inc. for approximately 1,280 square feet of space located at 264 S. Arlington Street, Akron, in Council District 4, for cafeteria operations, for a one-year term, with four options to renew for an additional one-year term, for rent of \$1.00 per year; and

WHEREAS, on 11/20/08, the County Executive executed the aforementioned lease and an addendum to the lease governing the operation of the cafeteria; and

WHEREAS, the County and United Disability Services, Inc. wish to enter into a renewal (1st of 4) of and addendum of the renewal to the aforementioned lease for an additional one-year term, from 11/20/09 through 11/19/10, with two options to renew for an additional one-year term; and

WHEREAS, at its August 26, 2008 meeting, the Summit County Children Services Board adopted Resolution No. 08-2008-26/F, which is attached as Exhibit A, which approved a contract with United Disability Services, Inc. to institute an on-site food service program and no further Board approval is necessary to renew the lease; and

WHEREAS, because United Disability Services, Inc. is a non-profit corporation and is leasing the space for educational and/or charitable purposes, the approval of the Board of Control is not required pursuant to Section 177.17(e) of the Codified Ordinances of County of Summit; and

WHEREAS, County Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the renewal of (1st of 4) and the addendum of the renewal to the aforementioned lease; the contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
