A Resolution authorizing the County Executive to execute a renewal (2<sup>nd</sup> of 3) of a lease of County real property with the Northeast Ohio Four County Regional Planning and Development Organization ("NEFCO"), for approximately 5,000 sq. ft. of space at 180 E. South Street, Akron, Ohio, in Council District 5, for the period 6/1/10 through 5/31/11, in the amount of \$2,510.15/mo., for a total annual amount of \$30,121.80 for the term, with one option to renew for an additional one year term, for the Executive's Department of Community and Economic Development and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2008-282, which authorized the County Executive to execute a lease of County real property, subject to the approval of the Board of Control, with the Northeast Ohio Four County Regional Planning and Development Organization ("NEFCO"), for approximately 5,000 sq. ft. of space at 180 E. South Street, Akron, Ohio, in Council District 5, in the amount of \$2,510.15/mo., for a total annual amount of \$30,121.80 for a one-year term, from 6/1/08 through 5/31/09, with three annual options to renew for an additional one-year term; and

WHEREAS, Council subsequently approved Resolution No. 2009-175, which approved a renewal (1<sup>st</sup> of 3) of the lease for an additional one-year term, from 6/1/09 through 5/31/10; and

WHEREAS, the County and NEFCO wish to renew  $(2^{nd} \text{ of } 3)$  the lease for an additional one-year term, from 6/1/10 through 5/31/11, at the same rent; and

WHEREAS, because NEFCO is a governmental organization, the approval of the Board of Control is not necessary pursuant to Section 177.17(e) of the Codified Ordinances of the County of Summit; and
