7 **A Resolution confirming an award by the Board of Control of a purchase order with Union**  
8 **Springs Pharmaceuticals for 2,850 units of MyClyns Personal Protection Spray, as Sole**  
9 **Source, in an amount not to exceed \$39,757.50, for the Executive's Department of Law –**  
10 **Public Safety Division, Emergency Management Agency, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 17, 2010, has awarded a  
13 purchase order for protection spray, as Sole Source, subject to confirmation by County Council;  
14 and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Union Springs  
25 Pharmaceuticals for 2,850 units of MyClyns Personal Protection Spray, as Sole Source, in an  
26 amount not to exceed \$39,757.50, is hereby confirmed, and the County Executive is authorized  
27 to execute such a purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
32 welfare of the citizens of the County of Summit and for the further reason of immediately  
33 providing protection spray.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
45 deliberations of this Council and of any of its committees that resulted in such formal action,
