12 WHEREAS, the Board of Control, at its meeting held March 10, 2010, awarded a
13 contract to provide the aforementioned services, subject to confirmation by County Council; and,

15 WHEREAS, County Council has determined by reviewing all pertinent information that
16 the contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a professional service contract with the County of
24 Summit Clerk of Courts for IV-D Provider services for child support enforcement, for the period
25 1/1/10 to 12/31/10, in an amount not to exceed \$239,575.00, is hereby confirmed and the County
26 Executive is hereby authorized to execute such a contract.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned services.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.
