12 WHEREAS, the Board of Control, at its meeting held March 10, 2010, has awarded a
13 purchase order for the aforementioned vehicles, under CUE pricing, subject to confirmation by
14 County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Montrose Ford for three
25 2010 Ford Crown Victoria police interceptor vehicles, under CUE pricing, in the amount of
26 \$23,138.81 each, for a total amount not to exceed \$69,416.43, is hereby confirmed, and the
27 County Executive is authorized to execute such a purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety, and
32 welfare of the citizens of the County of Summit and for the further reason of immediately
33 providing the aforementioned vehicles.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.
