7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award by the Ohio Association of Second Harvest Food-banks ("OASHF") of an**
9 **Ohio Benefit Bank grant for the period 1/18/10 through 6/30/10 in the amount of**
10 **\$15,140.00 of Temporary Assistance to Needy Families ("TANF") funds, with no local cash**
11 **match requirement, and appropriating these funds for capacity building and tax services**
12 **expenditures through 6/30/10, for the Executive's Department of Job & Family Services,**
13 **and declaring an emergency.**

15 WHEREAS, the Executive's Department of Job & Family ("DJFS") Services has been
16 awarded an Ohio Benefit Bank grant from OASHF which is a 501(c)3 organization, for the
17 period 1/18/10 through 6/30/10, of TANF funds in the amount of \$15,140.00, for capacity
18 building and tax services expenditures; and

20 WHEREAS, these funds will support free tax assistance, and when appropriate, help
21 families complete the Free Application for Federal Student Aid; and

23 WHEREAS, these funds are TANF dollars which is intended to provide services for
24 families with children, however, other populations may also be served; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to authorize the Executive to execute
28 any documents necessary to accept the award of the aforementioned grant from the Ohio
29 Association of Second Harvest Food-banks, and to appropriate these grant funds;
