7 **A Resolution appropriating funds in the amount of \$68,000.00 in the Clerk of Courts**
8 **Computerization Fund for the period ending 12/31/10, for the Clerk of Courts, and**
9 **declaring an emergency.**

11 WHEREAS, the Clerk of Courts office reduced the Clerk's General Fund Salaries
12 appropriation to meet the 2010 target budget but mistakenly did not sufficiently increase the
13 Clerk of Courts Computerization Fund budget to absorb a shift in employees; and

15 WHEREAS, additional appropriations are required in the Clerk of Courts
16 Computerization Fund to correct the appropriations for the 2010 operating budget and are needed
17 to meet projected expenditures for the balance of 2010; and

19 WHEREAS, this Council has determined by reviewing all pertinent information that the
20 appropriation of the aforementioned funds is necessary and in the best interest of the County of
21 Summit;
