22	WHEREAS, NDS has agreed to construct safe, sanitary and affordable homes on the		
23	parcels for purchase by low and moderate income persons and the County has determined it to be		
24	in its best interest to develop the property in such a manner; and

20	Summit, this Council must approve and authorize the sale of any County real property to a		
28	nonprofit corporation for low to moderate income housing purposes; and

30	WHEREAS, this Council has determined by reviewing all pertinent information that it is		
31	necessary and in the best interest of the County of Summit to authorize the County Executive to		
32	execute a Real Estate Purchase Agreement with NDS for the sale of the two parcels of County		
33	real property for the aforementioned reasons;

44	\$1.00 for each parcel. The Real Estate Purchase Agreement is approved with changes therein		
45	not inconsistent with this Resolution and not substantially adverse to the County which shall be		
46	approved by the County Executive; provide that the approval of those changes by the County		
47	Executive and the character of such changes as not being substantially adverse to the County		
48	shall be evidenced conclusively by the execution of the Real Estate Purchase Agreement.

16	property and pay any taxes and assessments during the time of construction.
