13 WHEREAS, the County of Summit is in receipt of carryover Home Weatherization
14 Assistance Program ("HWAP") grant funds from the State of Ohio through the American
15 Recovery and Reinvestment Act of 2009 ("ARRA"), in the amount of \$37,493.22, which provide
16 funding for necessary home improvements to low income citizens; and

18 WHEREAS, the ARRA HWAP carryover grant funds, which were made available
19 through 3/31/11, were originally accepted and appropriated pursuant to Resolution No. 2009-
20 246; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that it is
23 necessary and in the best interest of the County of Summit to appropriate the aforementioned
24 carryover grant funds, in the amount of \$37,493.22, for the period through 12/31/10;
