7 **A Resolution, pending Board of Control approval, authorizing the Executive to execute**
8 **Change Orders and Amendments to various Workforce Investment Act Youth**
9 **Agreements, attached hereto as Exhibit A and incorporated herein as if fully restated, to**
10 **add funds from the American Recovery and Reinvestment Act (ARRA) Temporary**
11 **Assistance to Needy Families (TANF) Emergency Contingency Fund as allocated by the**
12 **Ohio Department of Job and Family Services for a TANF Subsidized Summer**
13 **Employment Program for Youth Allocation as well as funds from the Executive's**
14 **Department of Job and Family Services' formulary TANF Allocation in an amount not to**
15 **exceed \$2,580,411.21 for the Executive's Department of Job and Family Services and**
16 **declaring an emergency.**

17
18 WHEREAS, the American Recovery and Reinvestment Act of 2009 ("ARRA") provided
19 Summit County with TANF Emergency Contingency federal stimulus allocations for allowable
20 expenditures made between 6/1/10 and 8/31/10 with a liquidation period by 9/30/10; and

22 WHEREAS, this Council is currently considering a Resolution which will authorize the
23 County Executive to accept the award by the Ohio Department of Job and Family Services
24 (ODJFS) of \$2,226,474 in TANF Emergency Contingency allocation and appropriating said
25 allocations; and

27 WHEREAS, through Resolutions 2009-162, and 2009-213 this Council previously
28 authorized SFY 2010 WIA Youth Agreements with these Providers; and

30 WHEREAS, the County of Summit wishes to enact Amendments and Change Orders to
31 currently existing WIA educational and employment services contracts with the providers listed
32 in Exhibit A, attached hereto and incorporated herein as if fully restated, and to authorize the
33 County Executive to execute said Amendments and Change Orders, subject to the approval of
34 the Board of Control, with said providers, for youth summer employment programs, for the
35 period 6/1/10 through 9/30/10, in a total amount not to exceed \$2,580,411.21; and

37 WHEREAS, subject to Board of Control approval, this Council has determined by
38 reviewing all pertinent information that these Change Orders and Amendments are necessary and
39 in the best interest of the County of Summit.

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The award, pending Board of Control approval, of Change Orders and Amendments to
47 WIA Youth Agreements for the period June 1, 2010, through September 30, 2010, with the
48 Providers listed on Attachment "A" in an amount not to exceed \$2,580,411.21, is hereby
49 confirmed, and the County Executive is authorized to execute all related documents.

7 welfare of the citizens of the County of Summit and for the further reason that the Change
8 Orders and Amendments are needed in order to enact a Summer Youth Employment Program in
9 Summit County.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
15 and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and of any of its committees that resulted in such formal action,
