7 **A Resolution appropriating funds for the second year of a three-year Felony Drug Court**
8 **Enhancement Grant from the U.S. Department of Health and Human Services' Substance**
9 **Abuse and Mental Health Services Administration ("SAMHSA"), with no local cash match**
10 **requirement, for an Oriana House program, in the amount of \$265,757.00, for the calendar**
11 **year ending 12/31/10, for the Court of Common Pleas-General Division, and declaring an**
12 **emergency.**

14 WHEREAS, the County of Summit received an award from the U.S. Department of
15 Health and Human Services' SAMHSA, which was accepted in Resolution No. 2008-503, for the
16 period that would extend through 9/29/11, to provide case management services though Oriana
17 House, Inc.; and

19 WHEREAS, Resolution No. 2008-503 also appropriated \$265,757.00 for the initial 2009
20 contract period, and now the second year of the Oriana House case management services
21 requires an appropriation for calendar year 2010; and

23 WHEREAS, the case management services provided by Oriana House, Inc. will enhance
24 the treatment services for drug-related offenders; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to appropriate the aforementioned
28 funds in the amount of \$265,757.00;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
