7 **A Resolution appropriating additional Temporary Assistance to Needy**
8 **Families/Subsidized Employment Program (“TANF/SEP”) funds received from the Ohio**
9 **Department of Job and Family Services (ODJFS), in the amount of \$27,843.50 through**
10 **9/30/10, for the Executive’s Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, ODJFS had state funds which it awarded throughout Ohio as TANF/SEP
14 and is now redistributing the funds which were returned as unspent by other Ohio counties; and

15
16 WHEREAS, TANF funding was accepted and appropriated as part of the Executive’s
17 Department of Job and Family Services’ funding in Resolution No. 2009-469, and the SEP
18 program is a division of the TANF funding with a program year of 11/1/09 through 9/30/10; and

20 WHEREAS, the additional TANF/SEP funding of \$27,843.50 will bring the total
21 received by the County of Summit in this program year to \$584,135.50, primarily to help
22 employers cover the cost of wages and benefits to qualified employees and to help support other
23 employee related expenses including, but not limited to, required work uniforms or tools and
24 training; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to appropriate the aforementioned
28 funds in the amount of \$27,843.50;
