12 advertise for bids for kitchen equipment for the County of Summit Jail, for an estimated cost not
13 to exceed \$135,782.00; and

16 Council; and

18 WHEREAS, this Council has determined by reviewing all pertinent information that it is
19 necessary and in the best interest of the County of Summit to authorize County Executive to
20 advertise for bids for kitchen equipment for the County of Summit Jail, for an estimated total
21 cost not to exceed \$135,782.00;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that;

27 The County Executive is authorized to advertise for bids for kitchen equipment for the
28 Summit County Jail, for an estimated total cost not to exceed \$135,782.00.

32 This Resolution is hereby declared an emergency in the interest if the health, safety, and
33 welfare of the citizens of the County of Summit, and for the further reason that it immediately
34 authorizes advertisement for bids for kitchen equipment for the County of Summit Jail, for an
35 estimated total cost not to exceed \$135,782.00.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.
