13 supervision and administrative expenses as a match required by an American Recovery and
14 Reinvestment Act of 2009 ("ARRA") TANF grant awarded to the County of Summit for the
15 YES Summer Youth Program; and

17 WHEREAS, \$23,900.00 in original appropriations require an adjustment in order to meet
18 projected expenditures; and
