7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Staples for merchandise cards for school supplies for TANF-eligible families with school-**
9 **age children, and adults enrolled in higher education or vocational classes, in an amount**
10 **not to exceed \$219,978.05, for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 22, 2010, awarded a
14 purchase order to provide the aforementioned merchandise cards, subject to confirmation by
15 County Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase order with Staples for merchandise
26 cards for school supplies for TANF-eligible families with school-age children, and adults
27 enrolled in higher education or vocational classes, in an amount not to exceed \$219,978.05, is
28 hereby confirmed and the County Executive is hereby authorized to execute such purchase order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned merchandise cards.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
