7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with GPD Group for project management services for the construction of a**
9 **communication tower for use with the 800 MHz system, in an amount not to exceed**
10 **\$40,000.00, in Council District 1, for the Executive's Department of Administrative**
11 **Services/Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 20, 2010, awarded a
14 contract to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a professional service contract with GPD Group
25 for project management services for the construction of a communication tower for use with the
26 800 MHz system, in an amount not to exceed \$40,000.00, in Council District 1, is hereby
27 confirmed and the County Executive is hereby authorized to execute such contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned services.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
