7 **A Resolution appropriating a Fiscal Year 2009 Metropolitan Medical Response System**
8 **(“FY09 MMRS”) grant, received from the Ohio Emergency Management Agency, of**
9 **federal funds in the amount of \$321,221.00 with no local cash match requirement, for**
10 **expenditures through 12/31/10, for the Executive’s Department of Law, Division of Public**
11 **Safety-Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, the Ohio Emergency Management Agency has awarded the Executive’s
14 Department of Law, Division of Public Safety-Emergency Management Agency an FY09
15 MMRS grant, in the amount of \$321,221.00, in order to provide the capability to better mitigate,
16 prepare, respond and recover from an act of terrorism and other disasters within the medical and
17 first responders community, for the period 8/1/09 through 7/31/12; and

19 WHEREAS, the Summit County Executive was authorized by the Summit County
20 Council to accept the FY09 MMRS grant in Resolution No. 2010-123 adopted on 3/29/10; and

22 WHEREAS, these FY09 MMRS funds must be appropriated in calendar year 2010 to
23 directly support Ohio’s Investment Initiative and Target Capabilities as approved by the U.S.
24 Department of Homeland Security; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to appropriate the aforementioned
28 funds in the amount of \$321,221.00;
