WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health ("ADM") Services Board has certified that pass-through grant funds are available, primarily from the State of Ohio Department of Mental Health, in the amount of \$380,509.00, with no local cash match requirement, for the period 1/1/11 through 12/31/11; and

WHEREAS, additional carryover grant funds in the amount of \$35,337.00, with no local cash match requirement, are available along with the aforementioned 2011 award; and

WHEREAS, the Psycho-Diagnostic Clinic is needed to provide court-ordered evaluations in criminal cases, and the aforementioned monies will be used to reimburse the Clinic for expenditures; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned grant funds in the total amount of \$415,846.00, with no local cash match requirement;
