A Resolution appropriating carryover grant funds received from the State of Ohio Department of Rehabilitation and Corrections for the Community Corrections Act ("CCA") 407 and 408 grants, in the amount of \$212,949.22, with no local cash match requirement, through 6/30/11, for the Executive's Department of Law, Public Safety-Justice Affairs Division and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Corrections, through the CCA, makes funds available to assist community in providing alternatives to prison for low risk offenders ("407funds"); and

WHEREAS, the State of Ohio Department of Rehabilitation and Corrections through the CCA, makes funds available to assist communities in providing programs that will reduce the reliance on the local jails ("408 funds"); and

WHEREAS, the State of Ohio has awarded the County of Summit both 407 and 408 CCA grant funds, which were accepted and appropriated in Resolution No. 2010-207 and Resolution No. 2010-208, and \$212,949.22 remains available, with no local cash match requirement, through 6/30/11; and

WHEREAS, these CCA grant awards provide funding to the Court of Common Pleas Adult Probation Department, the Sheriff's Misdemeanor Residential and Jail Reduction Programs and Oriana House, Inc.; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned funds in the amount of \$212,949.22;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
