An Ordinance amending Section 923.01(b) of the Codified Ordinances of Summit County to correct a clerical error by adding a table in said Section, for the Executive's Department of Environmental Services, and declaring an emergency.

WHEREAS, County Council previously adopted Ordinance No. 2008-021, which amended Section 923.01 of the Codified Ordinances of the County of Summit, entitled "User Charges", to include a notation to the first table in Section 923.01(b); and

WHEREAS, the second table in Section 923.01(b) was inadvertently left out of the text of Ordinance No. 2008-021; and

WHEREAS, it is necessary to amend Section 923.01(b) to correct the clerical error in Ordinance No. 2008-021 by adding in the aforementioned second table; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to amend Section 923.01(b) for the aforementioned purpose; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Section 923.01(b) of the Codified Ordinances of Summit County is hereby amended to add the second table in said Section:

"923.01 USER CHARGES.

(b) Effective January 1, 2007. Users whose water consumption is measured by meter readings provided to the County or whose sewage flows are metered shall pay the following monthly rates for all normal strength sewage or wastewater discharged into the County's sewage disposal system per the following schedule for the period 2007-2011:

SECTION 2
