	WHEREAS, facilities at the Triple Crown Restaurant, located at 335 South Main Street in the City of Munroe Falls, in Council District 2, have been proposed by the Engineer as an appropriate place to hold said meeting; and	
	WHEREAS, Prosecutor's Opinion 89-084 concludes that the cost of a dinner meeting for said event is a proper expenditure, payable from the Engineer's road and bridge funds; and	
	WHEREAS, Section 177.25(b) of the Codified Ordinances of the County of Summit permits certain entities including the Engineer, to make expenditures not exceeding \$2,000.00 annually for employee training, organization strategic planning meetings and meetings of boards and commissions; and	
	WHEREAS, Section 177.25(c) requires Council approval for all expenditures for	

or all expenditures for hospitality items for purposes other than the aforementioned purposes; and
