13 WHEREAS, the Board of Control, at its meeting held May 18, 2011, awarded a contract
14 to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the renewal is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a professional service contract with YMCA of
25 Akron, Inc., for the first renewal of two, for drop-in child care services at The Job Center for all,
26 regardless of income, for the period 7/1/11 to 6/30/12, in an amount not to exceed \$67,200.95, is
27 hereby confirmed and the County Executive is hereby authorized to execute such contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further purpose to immediately
33 provide the aforementioned services.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.
