7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Schindler Elevator for the five-year full maintenance service agreement for five elevators at**  
9 **the County of Summit Courthouse Complex, 209 South High Street, Akron, Ohio 44308, in**  
10 **Council District 4, in an amount not to exceed \$69,624.00, for the Executive's Department**  
11 **of Administrative Services – Physical Plants, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 15, 2011, awarded a purchase  
14 contract to provide the aforementioned agreement, subject to confirmation by County Council;

17 WHEREAS, County Council has determined by reviewing all pertinent information that  
18 the purchase contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a purchase contract with Schindler Elevator for the  
26 five-year full maintenance service agreement for five elevators at the County of Summit  
27 Courthouse Complex, 209 South High Street, Akron, Ohio 44308, in Council District 4, in an  
28 amount not to exceed \$69,624.00, is hereby confirmed and the County Executive is hereby  
29 authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide the aforementioned agreement.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.
