7 **A Resolution confirming an award by the Board of Control of various professional service**  
8 **contracts per attached Exhibit A for service providers for delinquent care and custody**  
9 **grant services, for the period 7/1/11 to 6/30/12, with three options to renew for a one-year**  
10 **period, in a total amount not to exceed \$520,000.00, for the Court of Common Pleas –**  
11 **Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 15, 2011, awarded contracts  
14 to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the contracts are necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

24 The award by the Board of Control of various professional service contracts per attached  
25 Exhibit A for service providers for delinquent care and custody grant services, for the period  
26 7/1/11 to 6/30/12, with three options to renew for a one-year period, in a total amount not to  
27 exceed \$520,000.00, is hereby confirmed and the County Executive is hereby authorized to  
28 execute such contracts.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.


