7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services for grants received by the County**
9 **Executive's Department of Job and Family Services during State Fiscal Year ("SFY") 2012**
10 **(7/1/11 through 6/30/12) and State Fiscal Year ("SFY") 2013 (7/1/12 through 6/30/13), for**
11 **the Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,
14 that the Ohio Department of Job and Family Services may only make grants to counties through
15 subgrant agreements as described in that Section; and

16
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio
18 Department of Job and Family Services developed a standard subgrant agreement to be executed
19 by the commissioners of each county prior to receiving Department of Job and Family Services
20 grant funds; and

22 WHEREAS, the County of Summit Department of Job and Family Services has received
23 from the Ohio Department of Job and Family Services the standard subgrant agreement for SFY
24 2012 (7/1/11 through 6/30/12) and SFY 2013 (7/1/12 through 6/30/13) that sets forth the rights
25 and responsibilities of both the Ohio Department of Job and Family Services and the County
26 Executive's Department of Job and Family Services in relation to any grant that is awarded for
27 SFY 2012 and SFY 2013; and

29 WHEREAS, the County of Summit Department of Job and Family Services anticipates
30 receiving grant funds from the Ohio Department of Job and Family Services for SFY 2012 and
31 SFY 2013; and

33 WHEREAS, this Council has determined by reviewing all pertinent information that it is
34 necessary and in the best interest of the County of Summit to authorize the County Executive to
35 execute said subgrant agreement for SFY 2012 and SFY 2013.

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The County Executive is hereby authorized to execute a subgrant agreement with the
43 Ohio Department of Job and Family Services for grants received by the County Executive's
44 Department of Job and Family Services for State Fiscal Year ("SFY") 2012 (7/1/11 through
45 6/30/12) and State Fiscal Year ("SFY") 2013 (7/1/12 through 6/30/13). A copy of said subgrant
46 agreement is attached hereto as Exhibit A and incorporated herein by reference.

8 immediately execute said subgrant agreement so that the County Executive's Department of Job
9 and Family Services is eligible to awarded grant funds from the Ohio Department of Job and
10 Family Services for SFY 2012 and SFY 2013.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and shall be in force at the earliest time provided by law.
