A Resolution authorizing the County Executive to execute Addendum No. 1 renewing a lease (third of four) with the Ohio Department of Public Safety-Bureau of Motor Vehicles for approximately 1,425 square feet of office space located at 1030 East Tallmadge Avenue, Akron, Ohio, in Council District 2, for a two-year term, from 7/1/11 through 6/30/13, for rent in the amount of \$863.38 per month, for a total amount of \$20,721.12 for the two-year term, for the Executive, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2005-462, which confirmed the award by the Board of Control of a lease with the Ohio Department of Public Safety-Bureau of Motor Vehicles ("ODPS-BMV") for approximately 1,425 square feet of office space located at 1030 East Tallmadge Avenue, Akron, Ohio, in Council District 2, for a two-year term, from 7/1/05 through 6/30/07, for rent in the amount of \$806.30 per month, for a total amount of \$19,359.20 for the two-year term, with four options to renew for an additional two-year term, and authorized the County Executive to execute the lease; and

WHEREAS, County Council previously adopted Resolution No. 2007-340, which confirmed the award by the Board of Control of a renewal (first of four) of the lease for a two-year term, from 7/1/07 through 6/30/09, for rent in the amount of \$843.39 per month, for a total amount of \$20,241.36 for the two-year term; and

WHEREAS, County Council previously adopted Resolution No. 2009-231, which awarded a renewal (second of four) of the lease for a two-year term, from 7/1/09 through 6/30/11, for rent in the amount of \$863.38 per month, for a total amount of \$20,721.12 for the two-year term; and

WHEREAS, the County and the ODPS-BMV wish to execute Addendum No. 1 renewing the lease for a two-year term, from 7/1/11 through 6/30/13, for the same rent; and

WHEREAS, because the ODPS-BMV is an agency of the State of Ohio, pursuant to Section 177.17(e) of the Codified Ordinances of the County of Summit, the approval of the Board of Control is not required for the renewal of the aforementioned lease; and
