7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
9 **one external, part-time, unclassified, Direct Indictment Officer I position, at a rate of pay**
10 **of \$14.90 per hour for 25 hours of work per week, to be funded in full through the Direct**
11 **Indictment Agreement with the City of Akron, for the Prosecutor, and declaring an**
12 **emergency.**

14 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted
15 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled
16 "Temporary Hiring Freeze," as a budgetary control measure; and

17
18 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
19 the filling of an existing position by hiring an employee is necessary for the effective and
20 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
21 said employees; and

23 WHEREAS, the County Prosecutor states that it is necessary for the effective and
24 continued operation of her office to be permitted to hire one part-time, unclassified, Direct
25 Indictment Officer I position, at a rate of pay of \$14.90 per hour for 25 hours of work per week,
26 to be funded in full through the Direct Indictment Agreement with the City of Akron; and

28 WHEREAS, this Council has determined, by reviewing all pertinent information, that it
29 is necessary and in the best interest of the County of Summit to authorize the County Prosecutor
30 to hire one part-time, unclassified Direct Indictment Officer I position;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
33 State of Ohio, that:

37 County Council hereby determines that the County Prosecutor has demonstrated that it is
38 necessary for the effective and continued operation of her office to authorize the County
39 Prosecutor, pursuant to Section 169.04(j) of the Codified Ordinances, to hire one part-time,
40 unclassified Direct Indictment Officer I position, at a rate of pay of \$14.90 per hour for 25 hours
41 per week.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the citizens of the County of Summit and for the further reason to immediately
47 authorize the County Prosecutor to hire said individual in order to continue effectively
48 prosecuting cases and collect revenue for Summit County.

16 121.22 of the Ohio Revised Code.


