A Resolution authorizing the County Executive to enter into an agreement with the Ohio Water Development Authority ("OWDA") for a loan in an amount not to exceed \$271,507.50 to finance the costs of the Pump Station Nos. 30 and 51 Force Mains Abandonment Project Q-944 ("Project"), in Council District 8, for the Executive's Department of Environmental Services, and declaring an emergency.

WHEREAS, in Resolution No. 2011-262, County Council awarded a contract to Wingfoot Rental and Development Company for construction of the Project in an amount not to exceed \$246,825.00; and

WHEREAS, the County desires to obtain a loan from the OWDA to finance the costs of the Project on the terms set forth in the Cooperative Agreement (defined below); and

WHEREAS, under the Cooperative Agreement, the OWDA shall disburse the amounts under the loan to Wingfoot Rental and Development Company upon pay request submittals by the County; and

WHEREAS, the OWDA has indicated its willingness to make a loan for that purpose and on those terms; and

WHEREAS, a draft of the Cooperative Agreement for the Project is attached as Exhibit A hereto and is on file in the Office of the Clerk of Council and at the Executive's Department of Environmental Services' State Road Office; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the County Executive to execute the Cooperative Agreement is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute the Cooperative Agreement with the Ohio Water Development Authority ("OWDA") substantially in the form as set forth in the "Cooperative Agreement for Construction, Maintenance and Operation of State Water Project or Wastewater Project," attached hereto as Exhibit A (the "Cooperative Agreement"), and any other related documents, for a 20-year loan, in an amount not to exceed \$271,507.50, to fund Pump Station Nos. 30 and 51 Force Main Abandonment Project Q-944 ("Project"). The interest rate for the 20-year loan shall not exceed 4.75% per year.

52 53 This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately finance the cost of Project Q-944, a needed sanitary improvement.
