A Resolution authorizing the County Executive to enter into a three-year policing agreement with the Township of Northfield Center, Council District 1, to provide 5.5 Sheriff's deputies, for the period 1/1/12 to 12/31/14, in the amount of \$586,316.67 for the first year, \$593,033.33 for the second year, and \$596,582.00 for the third year, for a total amount not to exceed \$1,775,932.00 during the three-year term of the agreement, for the Sheriff, and declaring an emergency.

WHEREAS, the Executive entered into a policing contract with the Township of Northfield Center which terminates 12/31/11; and

WHEREAS, the Township of Northfield Center hereby requests that the Executive enter into a new agreement to provide 5.5 Sheriff's deputies for the period 1/1/12 to 13/31/14; and

WHEREAS, the Township of Northfield Center has agreed to pay the County \$586,316.67 for the first year, \$593,033.33 for the second year, and \$596,582.00 for the third year, for a total amount not to exceed \$1,775,932.00 during the three-year term of agreement; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the Executive to execute the aforementioned agreement is necessary and in the best interest of the County of Summit;
